





25th Finswimming European Championship Lignano Sabbiadoro - Italy - 27 july 4 august 2014





RULES

1-DENOMINATION:

The F.I.P.S.A.S. with the agreement of C.M.A.S. has the pleasure to invite you at the "25TH Finswimming European Championship" in LIGNANO SABBIADORO from Sunday 27TH July to Monday 4 TH of August 2014.

2 - COMPETITION PLACE:

The Competition will be held in: Ge.Tur. Sport Village - Viale Centrale, 29 – Lignano Sabbiadoro (UD) - ITALY - Number 8 lanes, 50 meters long Olympic swimming pool features a constant depth 2,10 m.



3 -PARTICIPATION RULES AND RACES:

Eligible to participate at this Championship are the teams of National Federations, affiliated to CMAS. Each National team should comply with the Championship Rules, Safety Requirements set by the Organizers and all other CMAS Rules and Regulations.

Swimming pool events: Each national team should enter not more than two (2) competitors to each individual event and not more than one team to each relay.

Open Water events: Each national team should enter not more than four (4) competitors to each individual event and not more than one team to the relay.

National teams should bring two (2) national flags (m. 2,00 x m. 1,00) and a CD with the national anthem.

Swimming-pool races:

Apnea: 50m

Immersion: 100m, 400m,

Surface Finswimming: 50m, 100m, 200m, 400m, 800m, 1.500m

Bifins: 50m, 100m, 200m Relay: 4x100m, 4x200m

Open Water races (in the sea or in lake in case of bad conditions weather):

Individual : 6.000m, Relay : 4x2.000m

4-CLASSIFICATION AND AWARD, :

According to CMAS Rules and Regulations.

5-INTERNATIONAL JURY:

CMAS Technical delegate: according to CMAS Rules.

6 - PROTEST:

According to CMAS Rules .

7-BOTTLE FILLING:

Besides how much previewed from the Italian law (presence indication check "air", ministerial stamp every two years and/or certified of ministerial test), the bottles will have to be delivered in perfect state of physical integrity and will come loaded to the maximum pressure of 200 bars (atm).

They will not come accepted bottles with important signs of rust.

8 - DEADLINE, CONDITION FOR ENTRY AND PARTECIPATION:

• no later than 16Th March 2014

(Annex 1) The preliminary declaration of participation and registration form to the CMAS and Organizing Committee in Italy should be sent.

no later than 27Th Avril 2014 (Annex 6) Registration CMAS Finswimming Championship

no later than 11Th May 2014 (Annex 2) Preliminary Hotel Booking form and entry fee to the Organizing Committee in Italy has to be sent. (Annex 3) The letter proving the bank transfer should be sent to the Organizing Committee .

• no later than 15 June 2014

(Annex 4) Competitor's List has to be sent to CMAS HQ.

(Annex 5) Hotel Booking period is closed, Final Booking List has to be sent to the Organizing Committee in Italy. Participation declaration and bookings after the above indicated date would carry a 15% surcharge. We are calling all federations to observe this second deadline as hotels in the area are servicing tourism in the peak season, so the surcharge will be strictly applied.

10 -BOOKING AND ENTRY FEE:

> Choice 1: Entry fee for each participant is 800 Euro. The organizer will provide:

- Accommodations in hotel in rooms with three or four beds.
- Breakfast, lunch and dinner, beginning with the dinner of the 27 of July until the breakfast of the 4 of August 2012.
- Participation at the opening, closing ceremony.

> Choice 2: Entry fee for each participant is 700 Euro. The organizer will provide:

- Accommodations in hotel in rooms with three or four beds.
- Breakfast, lunch and dinner, beginning with the dinner of the **27 of July** until the breakfast of the **3 of August 2014**
- Participation at the opening and closing ceremony.

> Choice 3: Entry fee for each participant is 330 Euro. The organizer will provide:

- Accommodations in hotel in rooms with three or four beds.
- Breakfast, lunch and dinner, beginning with the dinner of the 1 of August until the breakfast of the 4 of August 2014.
- Participation at the closing ceremony.
- > Transfer airport-hotel-airport 40 EURO per person.
- > Extra charges for single room is 30 Euro/day
- > Extra charges for **double room** is **15 Euro/**day for person.
- > Extra day expenses 80 Euro per extra day, including 3 meals and accommodation in hotel in rooms with three or four beds.
- > Swimming pool charges: 30 euro/lane for 60 minutes. To agree availability with organization

Minimum 50% of total entry fee should be deposited at our bank no later than 11 of May 2014 to guarantee the booking.

After this date (11 of May 2014) the participation fee will be add to 10% of the total amount. The balance payment should be made at the arrival.

Organizer can accept only cash and wire transfer (bank charges are due for remitter).

"Procedures and obligations for the organization of CMAS Championship":

1.21.2. D Day – 1 month

Deadline

For the entry on line of athletes participating at CMAS Championship or Games

- 1.21.2.1.At the day J-4 months, the entry will be on line for the name of athletes and it must be mandatory done by electronic way, through the CMAS website, observing the following steps if the entry form (enclosure 6) has been received in due time the NF proceed as point.
- a. The representative of each national federation, with his logins and passwords (see art. 1.14) can have access to the program for entering athletes
- b. He will choose the concerned championship
- c. By doing so, he will have access to the list of the members of his federation
 - Practising the discipline of the championship
- Having a sports license valid at the closing date of the championship of the concerned discipline (green bottom)

Having a sports license for the concerned discipline, but this license expired before the closing date of the championship (red bottom)

If the name of the athlete does not appear, this means ipso facto that this athlete does not have a sports license for the concerned discipline

- d. He will then click the name of the athletes to be entered
- e. Once the selection achieved, he will confirm his selection and the list of selected athletes will be automatically sent by email to CMAS and organising federation
- f. As concerns Finswimming only, the representative charged of entries will be directly addressed to OMEGA site asking him to insert, for each athlete, the races for which he /she is entered and the best time of athlete

No time, being less than the world record, may be recorded if not officially homologated as new world record.

g. After confirmation, this information will be automatically transmitted

To CMAS

To the organising federation or to the Organising Committee of CMAS Games

To the Chairman of the commission managing concerned discipline

- 1.21.2.2. The on line entry of participating athletes will be closed 15 days before the beginning of the championship
- 1.21.2.3.the on line changing of participating athletes will be closed 15 days before the date of beginning of the championship
- 1.21.2.4.If one federation rejects to use the electronic entry and it sends the list of attending athletes by mail, fax or email, involving useless work
- a. It will be requested to pay a fee of 25 EUR (twenty five euro) for athlete, official or staff.
- b. in that case, the deadline for the updating of the names of participating athletes is fixed 6 weeks before the date of beginning of the championship instead of the 15 days as by Art. 1.18.2.5

For the payment on CMAS account of the board and lodging expenses at CMAS Games

1.21.2.5. Federation must have paid on CMAS account the remaining settlement of its board and lodging expenses for all its attending members, taken into account the payment just made 3 months before the date of the championship (Art 1.20.1.6)

The sport event 25th Finswimming European Championship, organized by F.I.P.S.A.S. will involve the processing of your team members data.

With your signature, you are authorising us to process your team members data for possible transcriptions of interviews, comments or report of the event, or the acts related to the event. As well as the publication in the web site addressed to the explanation, promotion and/or revelations of the events.

We also inform you that punctually some images of your partecipants may appear in the followinf cases:

- to create promotional videos, recording both the interviews and the 25th Finswimming European Championeship or possible visual/sounded documentation related to the event, with revelation aim to news media such as TV, press and radio.
- For the advertising or sponsoring of the brand that takes part in the event.
