1.- ORGANIZATION: CMAS - World Underwater Activities Federation.
FEDAS - FECDAS - Finswimming Department.
FEDAS - FECDAS - Judgment Commission.

2.- COMPETITION FIELD: Swimming pool Sant Jordi
Characteristics: indoor, 50 meters, 8 lanes.

3.- RULES:

The competition is ruled by CMAS Finswimming Rules, by CMAS Finswimming World Cup Rules, and by these Particular Rules that every athlete, with his/her enrolment affirms to know and to agree to follow.

4.- CATEGORIES:

The categories will be according to CMAS Finswimming World Cup Rules:

Junior: Categories (B) 16-17 years.
(C) 14-15 years.
(D) 12-13 years.

Senior: Category (a) 18 years and over.

* The minimum age to participate in Junior category will be 12 years.

* The minimum age to participate in Senior category will be 15 years.

5.- RACES:

The races that will be swum will be the following ones:

Women: 50AP, 100IM, 50FS, 100FS, 200FS, 400FS, 800FS, 50BF, 100BF, 200BF, 4X100FS

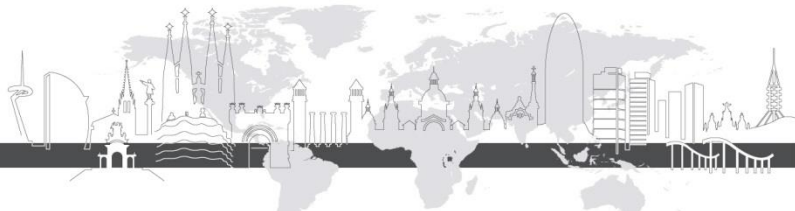
Men: 50AP, 100IM, 50FS, 100FS, 200FS, 400FS, 800FS, 50BF, 100BF, 200BF, 4X100FS

AP: Apnoea - IM: Immersion - FS: Surface - BF: Bifins

Each competitor can take part in a maximum of three (3) individual events and one (1) relay.

Each team can enrol a maximum of two (2) swimmers for each individual event.

"D" Group swimmers can't take part on 50AP races.



The races program will be in agreement with the CMAS regulations:

Day 1		Day 2	
1 st Session	- 50AP - 800FS	3 rd Session	-100BF -100FS -400FS
2 nd Session	- 50BF - 200FS - 100IM	4 th Session	-50FS -200BF -4x100FS

Swimmers should be ready with all the equipment to the orders of the Chief Judge at least 10 minutes before the beginning of their race.

6.- CLASSIFICATION:

There will be individual classification and clubs classification.

Individual: For each distance will be four classifications; Male, Female, Junior and Senior. Swimmers registered by Clubs or federations' Teams are in this classification.

Clubs: The general classification will be made by the total amount of individual points from the club members. Four separate Club Classification will be made; Male and Female, for Junior and Senior, according to the following CMAS scoring table:

The rest of the sportsmen who complete the race will receive 1 point per satisfactory participation.

7.- REGISTRATION:

The club or equipment that wishes to participate in this competition will have to complete the inscription form that is enclosed.

This inscription form, along with the payment voucher, must be received before day 13th of March of 2015 in the following email address: bcnwordlcup@fecdas.cat

In the subject it will have to appear: Registration World Cup BCN 2015.

Withdraws can be presented up to 5 days before the competition. Not later of day 16th of March of 2015. If they are not presented in that time, it will effective a penalty of 50.00 €.

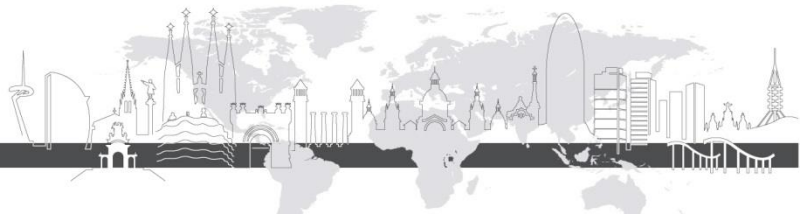

The clubs must send along with the inscription, the agreement from their National Federation, affiliated to the CMAS Finswimming Commission.

All the swimmers must be in possession of a valid CMAS Finswimming license. Pending licenses are not accepted (section 1.15.7 from the Procedures and Obligations document). This point will be verified at the end of the registration period.



Swimmers must appear inscribed by the same club throughout the year.

Relay teams must appear on the registration form, it is not necessary to detail the composition thereof.

8.- EQUIPMENT:

The swimmer's equipment must agree to the CMAS rules in force.

The bottles for the immersion races must have the inspection control with less than 2 years at the date of the competition. The bottles will have to display a proper state of conservation, without apparent damage or excessive rust.

The connection of the bottles must be type DIN200 or Yoke (A-clamp). For any other system the corresponding adapter must be provided by the competitor. The filling of the bottles will be made to a pressure of 200 bars.

9.- DOCUMENTATION/EQUIPMENT CONTROL:

The swimmers documents control, as well as the equipment control will take place on Friday the 20th of March of 2015 from 18:00h to 20:00h in the facilities of the competition swimming pool.

10.- ACCOMMODATION:

The organization will not arrange the accommodation for participants, but it offers them the attached list containing the hotels with the best prices in the city of Barcelona.
